GSB Face-to-Face Meeting

The Debtors Anonymous General Service Board met face to face in Newton, Massachusetts, from February 16 through February 19. The face-to-face meetings included informal and formal sessions of the GSB, its semi-annual check-in, and its semi-annual inventory. All GSB committees met to discuss progress since the 2016 WSC and to chart their paths for the next six months until the WSC in Dallas in August. The newer GSB trustees were able to visit the World Service Office in Needham. On Saturday the GSB invited the greater metropolitan membership of Boston to a "Meet the GSB session" in which the Office Finance, Literature, Communications and International committee chairs shared and took questions. Both Clay D., Class-A trustee and Pat B. Class B trustee and friend of D.A. shared their experience, strength, and hope about Board service.

Communications

In September of 2016, Communications Committee published the 3rd quarter edition of the D.A. Focus. In addition, it has continued to update the D.A.

International

The International Committee (IC) is actively working with countries from Europe and Central and South America in getting conferenceapproved D.A. Literature translated into German and Spanish. More international countries are forthcoming with their own translations waiting for approval. We are in contact with the European Regional Intergroup and the Asian Pacific Intergroup, working together on ideas for lowering the shipping costs for much needed D.A. literature from the General Service Office (GSO). We are also working with the Finance Committee in trying to set up the capability of debit card payments for international literature orders.

Literature Publications

The GSB Literature Publications Committee is responsible for the creation, publication, revision, and reprinting of D.A. literature, including books, pamphlets, and other items such as bookmarks and newcomer packets.

In terms of new literature, the committee is working on the following projects:

Twelve Promises pamphlet

- Anonymity pamphlet
- · Health Issues pamphlet
- BDA Tools and Signposts pamphlet
- · BDA Clarity in Business Finance pamphlet
- · BDA Numbers booklet
- BDA Annual Business Plan pamphlet

· Daily Meditation Book

Each project is on its own schedule for going through the Fellowship's conference-approved Literature Approval Process. Some projects seem to go through relatively easily, and others take more time to revise. While mindful of the Fellowship's desire to get the new literature published as soon as possible, we're also wanting to take the time to get things as right and solid as we can. We want to make sure we're sending the best possible material to the World Service Conference for approval.

On a different front, the committee is doing the footwork to resume selling D.A. books through online retailers. We had previously done this, but due to internal logistical challenges, stopped the process several years ago. We're now working to resume such sales with three prominent retailers, and hope to achieve results within this conference year.

Lastly, our committee is working in partnership with the WSC Literature Committee to develop a daily meditation book . . . more to be written about that project as it unfolds.

Audit

The GSB Audit Committee's primary responsibility is overseeing the accounting and financial reporting processes of the GSB and the annual review or audit of the GSB's financial statements. Additionally, the Audit Committee has oversight responsibility for selected GSB policies and internal controls.

The Audit Committee is responsible for retaining an Independent Certified Public Accountant (CPA) to prepare the annual financial statement review or audit and to complete the GSB's federal and New York State tax returns. The committee is required to seek competitive bids for CPA

services every five years. We have used our current CPA firm for four years, so we will be begin that process in the spring of 2018.

The committee is also responsible for ensuring that the Finance Committee, together with the CPA firm, has filed the tax returns by the November 15 deadline. Members of the 2015-2016 GSB Audit Committee began an indepth review of the Board's insurance policies and coverages. Based on the results of that review, the Board will have an opportunity to meet with our insurance agent in February 2017 to discuss any action that may be needed.

The Audit Committee also reviews and updates, as needed, the Composition, Scope and Procedure document, following guidelines for non-profit organizations incorporated in the State of New York.

Legal

The General Service Board Legal Committee has been busily preparing the necessary legal documents to begin selling D.A. literature from our web site via debit card transactions. This has included the drafting of a privacy policy to delineate how personal information will be collected for the sales as well as a refund and return policy. Additionally our two enthusiastic trustee members have been working with our intellectual property attorney to safeguard our ownership of the B.O.D.A. logo. An extension has been filed with the U.S. Trademark Office to insure that we are meeting all of their requirements before we officially re-register our "ownership." The committee has completed the re-registration and updates of copyrights to Debtors Anonymous literature, both new and

revised. It continues to be a busy but fulfilling time for our committee.

Nominations

The bulk of the work completed by the Nominations Committee during the fall of 2016 was procedural, with completion of an update of the committee's Composition, Scope and Procedures document. The committee is reviewing potential nominees for trustee positions. At this time, the Board has three trustee vacancies; two Class A (recovering debtor) Trustees and one Class B (non-debtor) Trustee. In addition, one Class A and one Class B Trustee are schedule to rotate off the Board in August, which will create a total of five openings: three Class As and two Class Bs. Applications for trustee should be sent to the General Service Office for consideration during the second half of the fiscal year and nomination at the 2017 Conference. Application for Appointed Committee Member (ACM) can be submitted anytime for consideration. Interested D.A. members may consult the D.A. Manual for Service, available on line. for the requirements to serve as a Trustee or an ACM.

- 'Compulsive Spending' pamphlet revision -- the concept of revising the 'Recovery from Compulsive Spending' pamphlet in order "to treat compulsive spending as a symptom of debting" was approved by the World Service Conference in 2013. Last year the 2015-16 WSC Literature Committee and GSB approved a draft but in a close vote the incoming 2016-17 WSC Literature Committee did not approve the draft for presentation at the 2016 World Service Conference and will make revisions to address concerns.
- Twelve Promises' pamphlet -the concept was approved by the
 World Service Conference in 2011, a
 1st draft was created by the WSC
 Literature Committee, a 2nd draft was
 approved by the 2014-15 WSC
 Literature Committee, a 3rd draft was
 approved by GSB Literature Services,
 this literature is now back with WSC
 Literature Committee for review.
- 'D.A. Basic Text' outline -2015-16 WSC Literature Committee
 approved a 1st draft outline and201617 GSB Literature Services approved
 a 2nd draft outline with comments.
 This literature is now with the 2016-17
 Literature Committee for review.
 At our October and November
 meetings, the WSC Literature
 Committee approved responses to
 three Issues & Concerns assigned to
 the committee.

The monthly teleconference meetings for this year's WSC Literature Committee have been very well-attended and productive with such a dedicated, dynamic group at both the committee and subcommittee level. My work as chair draws inspiration from all the activity; recently after hearing eloquent subcommittee reports during yet another incredible meeting I found myself gushing aloud, "It's like driving a Ferrari!" It's an honor and blessing to work with these talented D.A. members committed to carrying the message of D.A. recovery.

Business Debtors Anonymous

The long-awaited 12 Tools of BDA pamphlet is close to completion, and several other BDA-specific pieces of literature are currently in the pipeline...

Resource Development

The RDC is working on three projects this year, as follows:

- 1. Creating content and flyers about connection of spirituality and service equating to recovery
- 2. Fellowship-wide conference calls -inviting the fellowship to share their
 experience. RDC is working on topics
 for these calls, but the focus of the
 committee is DA self-support through
 service and financial contributions
 3. ACM Committee—attracting more
 ACM's to do service.

Diversity Caucus

The 2016-2017 Diversity Caucus is comprised of five D.A. members from a variety of communities across the United States and Canada. The mission of the Diversity Caucus is to support the Fellowship in carrying the message of Debtors Anonymous to the debtor in underserved populations and locations. We coordinate with all World Service Conference committees by developing best practices for doing service and sharing it with D.A. as a whole. This year's Diversity Caucus is working on the following initiatives:

 Creating a Fellowship-Wide Call to celebrate the diversity already in D.A., including speakers from underserved populations and locations who will share their experience, strength, and hope gained from recovery from compulsive debting.

Public Information

The WSC Public Information Committee is an enthusiastic group of 16, including members from Canada and the United Kingdom.

WSC PI's Statement of Purpose

"The Public Information Committee works to carry the message of D.A. to the still suffering debtor by interfacing with the media, helping professionals, the general public, and the D.A. Fellowship at large, in person, on the telephone and through written information. The Public Information Committee utilizes the Public Information Manual for Debtors Anonymous and other D.A. Service Literature available to the entire D.A. Fellowship as a tool for outreach efforts, and supports and trains regional PI Committees (PICs) and PI Representatives (PIRs) guided by the 12 Traditions of Debtors Anonymous."

The WSC PI Committee has four subcommittees who meet monthly to work on specific areas of outreach.

1. Helping Professionals Subcommittee

In October 2016, the Helping Professionals Subcommittee, together with members of the Northern California Intergroup, participated in the National Council of Bankruptcy Judges with a table staffed by longtime D.A. members. These members helped spread D.A.'s message by introducing Debtors Anonymous to bankruptcy judges, attorneys, and credit professionals, most of whom stated that they had never heard of our Fellowship. They were overwhelmingly supportive and one attendee was regretfully astounded that she had never heard of D.A., having spent her entire professional career working with people in debt: "How did I not know about this organization? Get out!"

2. Media Subcommittee

The Media Subcommittee has been preparing a script for a whiteboard video about Debtors Anonymous.

3. General Public Subcommittee

The General Public Subcommittee has submitted a proposal to GSB PI for distribution of D.A. contact cards to Intergroups to help kickstart outreach.

4. Fellowship at Large Subcommittee

The members of the Fellowship at Large Subcommittee led several WSC PI Committee members in a series of drop-in calls to work on a proposed Public Information Handbook, which was submitted to GSB PI for approval this December.

International Caucus

The International Caucus has met on a monthly basis since September 2016 in order to work on our stated priorities. To that end we've accomplished the following:

- 1. Working with a committee of representatives from Spanish-speaking countries, we helped them submit translations of DA literature for approval to the Board's International Committee
- 2. Working with representatives from France, we are helping them prepare their translations for submission
- 3. We are in the process of documenting contact information for representatives from several countries where DA meetings aren't being held 4. We have partnered with the
- Literature Committee on drafting a call for story submissions for a special edition Ways and Means. Longer stories may be considered for inclusion in the Basic Text
- 5. Once the Literature Committee has approval distribution of the announcement, we will forward it to our contacts around the world to help spread awareness
- 6. As a committee, we voted to ask our home meetings to join the G-Sponsor program in order to support

international meetings in need of assistance.

Intergroup Caucus

The Caucus over the last year focused on four areas, beginning each year with encouraging and helping Intergroups to update their information. An IG focused survey was used to measure knowledge and initiatives of Intergroups and is still being reviewed and analyzed for our use. Encouragement to provide and support the sponsorship of 40th Anniversary celebrations resulted in some great events shared by many. A service handbook is in the process of draft and review which will provide guidance and training

The table above shows income and expenses for the first third of this fiscal year, FY17, compared to our spending plan.

Because the WSC and John H. Scholarship Funds are special cases (see below) the most instructive line is "Net Operating Income." That line shows a year-to-date (YTD) deficit through October 31 of \$-16,555.96. This is less than the planned deficit of approximately \$-21,000, and it will be very interesting as we go through the remaining eight months of the year to see if book sales continue at anything like their current strong pace. If they do, our deficit will almost certainly be less than the planned \$-48,000 shortfall. The projected deficit will also be reduced if the downward trend in group contributions reverses, and if individual contributions continue to increase.

Although we are experiencing a deficit, we have had sufficient cash in our regular operating accounts so that we have not had to draw on our prudent reserve. The current deficit is lower than last year at this time.

However, the first-third expenses don't include the costs of the GSB winter face-to-face meeting, which took place February 16–19 in Needham, Massachusetts. Those expenses (lodging, meals, travel, and costs associated with a "Meet the Board" forum) were about \$8,000.00.

Income

<u>Book sales:</u> The Twelve Steps, Twelve Traditions, and Twelve Concepts of Debtors Anonymous, released in May of this year, accounts for the significant increase in book sales compared with the first quarter of FY16. Translated into carrying the message and unity, the FY17 book sales break down as follows:

- · A Currency of Hope: 221 copies
- "The Twelve Steps of Debtors Anonymous" booklet: 170 copies
- The "Twelves," paperback and hardcover combined: 1,383 copies

Contributions: Expenses

Two items make up most of the increase in expenses in the spreadsheet:

- the additional salary for the part-time employee
- the ongoing rental of a storage space that allows us to save on storage fees paid to our printers John H. Scholarship Fund and World Service Conference:

A reminder that the John H. Scholarship fund, though given as income and expense, is a pass-through item. That is, everything received is distributed. When Scholarship recipients return their unspent funds, that money goes into the next year's Fund.

Other Finance Committee activities
